**Subject** : FIA Standard 8877-2022 Protective Clothing for Karting Competitors –  
Implementation Plan

We would like to inform you that the FIA WMSC held on the 19 of October 2022 approved the following implementation plan for FIA Standard 8877-2022 Protective Clothing for Karting Competitors.

### **Implementation Plan**

- **19.10.2022** – Start accepting karting clothing according FIA Standard 8877-2022
- **31.12.2022** – Stop homologation of CIK-FIA standard 2013-1 overalls
- **01.02.2024** – Require Karting Gloves and Karting Shoes approved according to the FIA Standard 8877-2022 for FIA Karting Championships, Cups and Trophies\*
- **01.01.2025** - Compulsory Karting Gloves and Karting Shoes approved according to FIA Standard 8877-2022 in all Karting Competitions entered in the FIA International Sporting Calendar\*
- **31.12.2024** - Stop production of CIK-FIA standard 2013-1 \*\*
- **01.01.2030** - Only accept Karting Overalls according FIA Standard 8877-2022

\* If there are at least two different Manufacturers, and prices are similar to current products.

\*\* For clarity, overalls manufactured before 31.12.2024 will be accepted during their useful life, which is indicated on the label of the overalls, but not beyond 31.12.2029.

The Technical list listing the overalls approved according to CIK-FIA N2013 will also be updated. The overalls with an "End of Homologation" date after 31.12.2024, will have this date updated in the Technical List to the 31.12.2024, the validity of the overalls is also updated accordingly.

### **HOMOLOGATION PROCESS**

- Unlike the current CIK-FIA N2013-1 Standard, the homologation process for this new FIA standard will be the same process as for any other FIA safety standard (e.g. FIA Standard 8870-2018 Karting Body Protection).
- As some of the requirements of this new standard are similar to CIK-FIA N2013-1, the FIA has decided to implement a process to allow the Manufacturers with CIK-FIA N2013-1 to request a new homologation without needing to repeat all the tests. Manufacturers can request karting overalls to be approved according to FIA Standard 8877-2022 based on the current CIK-FIA N2013-1-approved overalls by submitting a homologation request dossier, which includes the following:
  - New test report containing:
    - Resistance to abrasion results according to the new test method (see Article 6.1)
    - Compliance with the new zoning requirements (see Article 4.1.3)
    - Dimensional change (see Article 6.5)
  - User manual, skin irritation declaration, presentation form and customisation certificate examples (see Article 5.3.1, Article 6.6 and Appendix F, respectively; the customisation certificate is also available upon request)
  - Overall sample including the FIA Homologation label and user information label (see Article 7)

- Tearing, tensile strength for structural seams and dimensional change test results of the CIK-FIA Homologation – test reports that are more than two years old will not be accepted

NOTE: this process is valid from 29 June 2022 to 30 June 2023
